# COVID-19 CORNER

If ANY household members exhibit any symptoms of COVID-19, even if mild, OR if they have been exposed to a COVID-19 positive person, OR if anyone in the household tests positive for COVID-19, that they must:

- 1. Contact the health department or their medical provider for guidance on testing
- 2. Immediately self-isolate the household until medically cleared. This includes any in-person contact including visitation, meetings, appointments etc.
- 3. Notify the child(ren)'s caseworker(s) and the licensing worker within the same business day


Attached to this email is information regarding court and the Child Welfare Court Process. The attachments are in English and in Spanish.

The first attachment is the Quick Guide for Families which contains the following; a roadmap of the court process with a brief overview of the steps involved in the Nevada Child Welfare Court Process and Ideal outcomes to preserve and reunify the family by making it possible for the child to be safe at home, and the information about how the Parent/Caregiver commitment to completing the requirements of their individualized Case Plan is crucial to helping that outcome become a reality.

The second, is a handbook regarding the court process. This handbook provides parents, relatives, and caregivers with information about what to expect when a child welfare agency becomes involved with your family.

The last attachment is a sample of a letter that you should be receiving to notify you of any upcoming hearing(s) for children in your home. This letter outlines your right (as the caregiver) to come to Court and speak for yourself, your family, and the child(ren) you are caring for. You are also encouraged to submit in writing to the assigned caseworker what you would like the Court to know and the caseworker will ensure the Court receives this information. In addition to the letter, there are question for you to till out if you cannot attend the court hearing and want to submit an update to the court regarding the child(ren) in your home.



## New Training updates:

Below are amazing new trainings that are on the QPI website that you can get renewal training hours!

How to Get the Job, Keep the Job (CC)

Our presenter is a former foster youth that shares helpful tips on how foster parents can help a youth get a job and maintain a job. The presenter discusses survival mode for youth and how this could be a struggle to maintain a job. How the youth can build a resume, search for work, and interview prep is also discussed, as well as soft and hard skills. 0.5 hour

#### Consent (CC)

Participants will learn the meaning of consent and when consent is true. They will learn how to teach children consent and the importance of boundaries and activities. They will learn how to report sexual assault. Participants will learn who the child can talk to when they are dealing with trauma. Participants will also learn about disclosures and how to handle them. 1.5 hours

#### Healthy Relationships (CC)

Participants will learn to identify different types and attributes of relationships children may be a part of in the modern world. They will learn to develop skills to effectively communicate with their children. They will be able to recognize and adapt to boundaries presenting in your children to strengthen relationships. They will learn to keep children safe on the internet. They will learn to support children through changes with friends while encouraging them to venture out and meet new types of people. 1.5 hours

Self Care: Not a Luxury, but a Necessity (CC)

Participants will learn to define self-care. They will learn to demonstrate simple self-care techniques. They will learn how the brain changes during stress. Participants will be able to demonstrate mindfulness. They will learn to understand the perception can be different among others but that does not make it wrong. 1.0 hour

#### Online Safety for Foster Parents (CC)

Participants will learn different social media platforms. They will learn to identify and understand risks foster children face on the internet. Participants will learn what to do and how to help children remain safe on the internet. 0.5 hours






# Meet our Family Engagement Center (FEC) Staff

# Washoe County School District

The District has extended the deadline to register for summer school to Friday, May 7 by midnight.

The summer school program is open for all WCSD students to provide extra academic support to prepare for the next school year. Summer school is also an excellent opportunity for students who have engaged through distance learning to transition to in-person learning and obtain additional social and emotional support to return to their schools.

#### 2021 Summer School

- Free to all K through 12-grade WCSD students
- Four consecutive weeks, starting on June 22 through July 15
- Each week on Tuesday, Wednesday, and Thursday for 5.5 hours.
- Breakfast and lunch will be provided, as well as transportation for students within a bus zone.
- Elementary and middle school students will get additional help with math, reading, and language arts in addition to fun and enriching activities.
- High School students will access specific programs at their school for credit recovery and accrual.
- To sign up for students currently attending kindergarten through 8th grade, families need to complete the <u>online summer school</u> registration.
- School sites are still being confirmed. Check with your school for more information.

#### **QPI KEYWORD**

#### Person Legally Responsible (PLR)

The Person Legally Responsible for the psychiatric care of a child. The PLR is solely responsible for making decisions related to the psychiatric care of a child, including consenting for such care and authorizing the administration of psychotropic medications.

#### **ONLY a PLR can:**

- 1. Make decisions about which psychiatrist is assigned to a child and specifically provide consent for that physician to see the child.
- 2. Schedule / reschedule / cancel psychiatric appointments for a child, except in an emergency situation; and
- 3. Consent to psychotropic medications.

#### Care Provider Responsibilities:

- A. The care provider will dispense psychotropic medications to the child as directed on the Psychotropic Medication Record and Informed Consent (HSACS 546) and will log this on the Prescription Medication Administration Log (HSACS 590).
- B. Provide copies of the Prescription Medication Administration Log (HSACS 590) to the PLR Unit at least monthly
- C. Monitor the child for any adverse reactions and immediately seek medical attention when a child has a severe adverse reaction. Notify the PLR and case worker immediately when the child experiences any adverse reactions to a medication.
- D. Store all prescription and non-prescription medication in a locked place that is inaccessible to children. Medications, such as inhalers and Epi-pens, that must be kept with the child at all times (pursuant to the instructions of a physician) are exempt from this requirement.

Ourpact is a parental control app that allows the parent to manage screen time, track their children, block, and allow access to any app; even texting, get alerts when their kids arrive and leave home, school, or anywhere, and allows for a screenshot view into their child's online activity. The app is FREE.

#### More about the App


- The App works for both android and I phone users.

# **ATTENTION**

Washoe County Case Workers and Licensing Personnel may conduct a home visit of a licensed foster home at any point, either scheduled or unannounced. Please be aware that the expectation during a home visit by any WCHSA staff is that all areas of the home are accessible, including but not limited to living spaces, bathrooms, and all bedrooms, including those of foster children, foster parents, biological children, boarders, and direct care staff. Although there may be areas of the home that are restricted from foster children, the entirety of the home should be available for inspection to confirm safe environments and regulation compliance.

This expectation is per **NAC 424.130 Section 3**, "A licensing authority representative shall inspect the entirety of each foster home and any attached property, including, without limitation, areas of the foster home and property that are not accessible to children, for safety. The licensing authority representative may take notes and photographs during the inspection." and per **NAC 424.355**, "A foster home should be reasonably accessible to ...visits from agency staff."

# Respite

Some good news! Alternative Care (Respite) funding has been approved for the next fiscal year July 1, 2020-June 30, 2021. This means each foster home has 7 days to use during that timeframe. Please note that if you have unused days from this fiscal year ending June 30, 2020, unfortunately those days do not carry over.

Please read the attachments on this email for further details on paid alternative care.

Currently, foster families are able to utilize this funding to take foster children on a family vacation as a family unit as long as approved by the child's caseworker.

If you submit a paid alternative care request form and do not have a response within 4 business days, please reach out as that may indicate your request was not received. Dear Foster Parent:

We are excited to announce that WCHSA has received alternative care funding through June 30, 2021! Each family\* is eligible for **7 days of paid alternative care** per fiscal year. The ongoing availability of this reimbursement program will be dependent on funds being available each year. Please note that with the addition of this funding, KK respite will be for emergencies only based on availability, agency discretion, and approval

Alternative care gives parents and children the chance to have short periods of time apart in which they can reset and recharge. It enhances the quality of care for the child, gives parents a deserved and necessary break, and ensures healthy and stable placements for all children by preventing parental exhaustion and burnout. Some parents also find that taking family vacations together is a means to recharge as a family. Therefore, alternative care funds may also be utilized to provide funding to include the foster children on a family vacation. WCHSA strongly discourages the use of alternative care for foster children so that families can take vacation without the foster children.

#### Requirements:

- Prior approval The WCHSA Paid Alternative Care Request Form must be submitted no later than one week in advance.
- Use of an approved licensed foster parent, cleared direct care staff, babysitter, or other approved
  care provider to provide the alternative care. Enhanced/SFC+ are required to use the same level
  provider (ex. SFC+ to use SFC+ provider). Please review the attached Alternative Care Policy.
- Paid alternative care days can be taken in increments from one day to seven days. WCHSA will track number of days used, so contact Victoria Bowers to check your remaining balance.
- Paid alternative care days not taken by June 30, 2020 are not carried over and will be forfeited.

#### Payment:

- Reimbursement will be \$30/day, per child (regardless of "normal daily rate") for all providers when taking a child/children on a family vacation. For paid alternative care, all families will be paid at a rate of \$30 per day per child with the exception of children placed in Specialized Foster Homes:
  - Will be paid to the licensed foster parent performing the care upon confirmation that the
    care was provided. In the case of other approved care providers, reimbursement will be
    paid to the foster parent requesting the care as they are expected to pay their care provider
    directly.
  - 2. Paid directly to the family if utilizing funds for a family vacation.
- The attached WCHSA Paid Alternate Care Request form must be submitted to take advantage of the respite reimbursement.

Use of alternative care beyond the seven days is allowed; however, it is the responsibility of the foster parent requesting care to pay the care provider directly. If you need assistance locating a care provider or have other questions about paid alternate care, please contact Victoria Bower at 337-4484.

\*Homes licensed for adoption only are, unfortunately, not eligible for this program.


