Child Labor Human Trafficking: Modern Day Slavery

Labor trafficked children are rarely recognized if systems and individuals zero in only on the victimization of children by sex traffickers. The children who are vulnerable to labor trafficking may have factors that can heighten the risk for them, including separation from families and supports, poverty, lack of educational opportunities and undocumented status. Child labor traffickers can be like any other traffickers: from family members to organized crime networks and forced labor of children can coincide with sex trafficking. This presentation is for anyone who has contact with children in our community: neighbors, school personnel, child welfare, law enforcement, justice system, attorneys, parents and grandparents - everyone! Experts will provide a survivor perspective and give attendees information about this current reality that is too often overlooked. (1.5 hour)

Tools for Maintaining African American Hair

This training addresses questions many foster parents have about caring for ethnic hair types. The training interviews two barbers on hair care routines, needs, and how to maintain the hair of foster youth. Many foster parents have questions and want to hear it from the experts. (0.5 hour)

Providing Support to Youth Who Have Experienced **Toxic Stress**

This video provides an overview of adverse childhood experiences and toxic stress, how toxic stress shows up in behavior and beliefs, as well as how to support youth who

have experienced or are experiencing toxic stress. Presented by licensed Marriage and Family Therapist, Barbara Lankamp-Kochis. (0.5 hour)

Creating Permanency for Youth

Youth transitioning out of foster care often come out at a disadvantage. The norm they had grown accustom to where supportive adults fulfill specific needs typically comes to an end when they leave foster care. However, that's when they actually need more supportive people and this training addresses the need. This training is designed to help caretakers have the conversations needed to discover the supports youth will have when they leave care. (1.5 hour)

COVID-19 CORNER

If ANY household members exhibit any symptoms of COVID-19, even if mild, OR if they have been exposed to a COVID-19 positive person, OR if anyone in the household tests positive for COVID-19, that they must:

- 1. Contact the health department or their medical provider for guidance on testing.
- 2. Immediately self-isolate the household until medically cleared. This includes any in-person contact including visitation, meetings, appointments etc.
- 3. Notify the child(ren)'s caseworker(s) and the licensing worker within the same business day.

Respite information

Dear Resource Family:

We have an exciting UPDATE regarding respite! Each family* is now eligible for up to <u>14</u> days of paid alternative care through June 30, 2022. If you already claimed 7 days since July 1, 2021, you are eligible to claim up to another 7 days. The ongoing availability of this reimbursement program will be dependent on funds being available. Paid alternative care days not taken by June 30, 2022, are not carried over and will be forfeited.

Alternative care gives parents and children the chance to have short periods of time apart in which they can reset and recharge. It enhances the quality of care for the child, gives parents a deserved and necessary break, and ensures healthy and stable placements for all children by preventing parental exhaustion and burnout. Some parents also find that taking family vacations together is a means to recharge as a family. Therefore, alternative care funds may also be utilized to provide funding to include the foster children on a family vacation. WCHSA strongly discourages the use of alternative care for foster children so that families can take vacation without the foster children.

Requirements:

- Prior approval The WCHSA Paid Alternative Care Request Form must be submitted no later than <u>one week</u> in advance. This form must be submitted to take advantage of the reimbursement.
- Use of an approved licensed foster parent or other approved provider to provide the alternative care. Enhanced/SFC+ are required to use the same level provider (ex. SFC+ to use SFC+ provider). Please review the attached Alternative Care Policy.
- Paid alternative care days can be taken in increments from one day to 14 days. WCHSA will track number of days used, so contact <u>HSA-RespiteRequests@washoecounty.us</u> to check your remaining balance.

Types of Alternative Care and Payment:

- 1. <u>Inclusive Respite:</u> WCHSA's Alternative Care Policy outlines the option to receive respite payments to off-set costs associated with taking the whole family, *inclusive of the foster children*, on a family vacation. These payments are paid directly to the foster parent with whom the foster child resides. Issuing respite funds as an *inclusion* is not a taxable event and therefore a 1099 tax form will not be issued. Inclusive respite reimbursement is \$40 per day per child.
- 2. Paid Alternative Care: WCHSA's Alternative Care Policy outlines the option for foster families to use funding to select and pay an alternate licensed foster parent directly. When an alternate caregiver is used to provide respite for a foster child and the respite payment is made directly to that alternate caregiver it is considered a taxable event, as it meets the IRS's definition of respite earnings. Therefore, a 1099 tax form will be issued to the alternate caregiver if their respite earnings for the calendar year total \$600 or more. A one-time completed W-9 must be submitted to HSA-RespiteRequests@washoecounty.us to receive payment. For a two-parent licensed foster home only one parent is required to submit a W-9 and will be the taxed individual. Upon WCHSA confirming that alternative care was provided, all alternative care respite providers will be paid at a rate of \$40 per day per child.
- 3. Other Approved Alternative Care Providers: WCHSA's Alternative Care Policy outlines the option for foster families to use other approved caregivers to provide respite, including cleared direct care staff, babysitters, and licensed childcare staff. These provider types are *eligible* for alternative care reimbursement. Providers must submit a copy of their identification, a completed Alternative Care Acknowledgement letter, and a completed W-9 to <u>HSA-RespiteRequests@washoecounty.us</u> to receive payment. Upon WCHSA confirming that alternative care was provided and the aforementioned documents are on file, all alternative care providers will be paid at a rate of \$40 per day per child. This payment is considered a taxable event by the IRS and providers will be issued a 1099 form if paid \$600 or more in a calendar year.

Use of alternative care beyond the 14 days is allowed; however, it is the responsibility of the foster parent requesting care to pay the care provider directly. If you need assistance locating a care provider or have other questions about paid alternate care, please email <u>HSA-RespiteRequests@washoecounty.us</u>.

*Homes licensed for adoption only are not eligible for this program.

Full Series: April 6th and 7th 9am-12pm NV TBRI Introduction and Overview Trust-Based Relational Intervention is an evidence-based, trauma-informed intervention.

This attachment-rich intervention is designed to meet the unique needs of children who have experienced trauma. Connection is the heart of TBRI. When children feel safe and know they have a voice, their survival behaviors: including lying, stealing and anger outbursts, are diminished.

When TBRI is applied, caregivers spend less time stressfully putting out fires and more time joyfully engaging their children. As a result, these children who desperately needed a sense of self-worth, begin to discover their value.

Family Engagement Center: COVID Information

FEC UPDATES 3-10-22





It's been a rough two years with a ton of changes and we are ready to get back to where we were in early 2020. General updates on the FEC moving forward:

Visitation (Family-Time) Scheduling:

- ✓ We will continue scheduling visitation based on the availability of both the parent and care provider.
- We will continue requesting care providers transport children to/from visitation, when able. When truly unable, Runners and FEC staff will be available to assist with transport needs.
- ✓ Increased visit times (length and frequency) as schedules allow for all families.
- ✓ We can once again include '<u>other approved visitors</u>' regardless of whether or not that person resides with the visiting parent. This is dependent on space/staffing and availability so talk with your engager.

Visitation (Family-Time):

- ✓ We continue to require all visitors to use hand sanitizer and temperature screening, upon entry.
- ✓ If you choose, face coverings can continue to be worn and/or others in your party may wear them.
- You (families) will have more freedom to choose where to spend their family time while at the FEC. They will have access to more activities, crafts, etc.
- You (families) will once again have access to cook and prepare meals together. Bring food in or use what we have available. You must clean up after yourselves, though.
- ✓ FEC staff are excited to get back to providing a 'normal', home-like environment for WCHSA families.

FAQ - Educational Quick Facts re. Youth in Foster Care

INCLUDING important WCHSA policy updates!! (Updated 9/30/21)

Did you know??

- SCHOOL OF ATTENDANCE: Foster youth have the right to remain at their School of Origin (see definition at end of document) when they come into care and/or change placements – even if it's an adoptive placement - to reduce additional disruptions and maintain their educational stability.
 - o WHY?
 - Often the school they attend when they come into care is the "only" stable environment in their world – while parents and placements are in flux.
 - Statistically, foster youth lose an average of 6 months of education for every school move/disruption.
 - WCHSA is bound by State and National legislation, to ensure that every effort is made to maintain our foster youth in their School of Origin.
 - IF it is determined to be in the best interest of the student to change schools, it MUST be approved by WCHSA leadership. This process is coordinated through the student's worker and the WCHSA educational liaison.

Frequent Asked

- Foster Parents, relatives and fictive kid CANNOT change a youth's school without proper approval through WCHSA.
- TRANSPORTATION: Mileage reimbursement is available to whomever is assisting with transportation if there is
 no bus available. This applies to "anyone" transporting the youth, while the case is open.
 - The district tracks the miles, so you don't have to! The reimbursement is one round trip, based on mapped miles between school and placement address and is disbursed once a month (electronic payments are available!) for the prior month of transport.
- STRONG COMMUNICATION IS KEY
 - o The relationship with your student's school is your first line of defense in providing support.
 - o Communicate with your worker when things get confusing or challenging.
 - 0
- INFINITE CAMPUS: Get acquainted with Infinite Campus to follow student progress provide kudos earned and track missing assignments. "It takes a village" and caregivers are an essential part of that village!
